


We concluded the week with another 4 CEM side events. This morning began with an EVI call for action, where we saw, Fatih Birol, Dave Turk, Claire O'Neill, Mollie Johnson and Chen Linhao present their thoughts on closing the gap to 2030 and getting the world on track to long-term climate and energy targets, including net-zero emissions pledge.

In our next event [Green Hydrogen: Accelerating Decarbonisation in Developing Countries](#) the World Bank's Demetrios Papathanasiou was joined by Andrea Meza Murillo, Minister of Environment and Energy of Costa Rica and Francisco Lopez, Undersecretary of Energy of Chile to discuss how the two countries are pursuing green hydrogen plans, explaining their vision of how green hydrogen can play a role to accomplish their decarbonization goals and development objectives, and the elements required to scale up green hydrogen production and use sustainably.

A high level panel including Secretary Granholm, Minister Trevelyan and Minister O'Regan joined C3E international and the SDG7 Youth Constituency to highlight the important role of women and youth in the transition to clean energy. [The event](#) showcased the CEM's focus on gender equality and fostered intergenerational dialogue on this important matter. Ministers and youth representatives exchanged thoughts and ideas on the importance of equality for the energy sector.

Bringing our week of exciting events to a close we saw Francisco Javier López, Chilean Undersecretary of Energy, joined by a panel of experts including Jennifer Layke from WRI explore a range of topics such as how governments can accelerate clean energy adoption with new frameworks, how public-private collaboration can reduce risk to scale investment, and how partnerships like the International Solar Alliance can mobilize [clean energy finance](#).
